**SASKATCHEWAN BISON ASSOCIATION SHOW & SALE  
RULES AND REGULATIONS:**

---

- **Exhibitors** must be members in good standing of the Canadian Bison Association
- **Import and export:** farmed bison within all provinces except **British Columbia** are considered to be bovine and follow cattle regulations. For movement within Canada, a Record of Movement of Bison is required by the CBA & SBA.
- **Judges & Yard Staff** reserve the right to reject or disqualify any animals from the show or sale if in their opinion the animal appears to be diseased, injured in any way, appear to be in an unhealthy condition or wrong age.
- **Entry Deadline:** 4:00p.m., January 15, 2019

- **Class Limits:**

- **Yearling Bulls- Maximum 24 Bulls**
- **Bred Heifers- Maximum 25 Breds**
- **Pen of 3 Heifer Calves- Maximum 25 Pens (75 head)**
- **Pen of 2 Yearling Heifers- Maximum 25 Pens (50 head)**

- **Commission:** A commission of 8% plus G.S.T., will be deducted from the gross sale price of each animal sold at the auction.
- **Horns:** Both horned and dehorned animals will be accepted. Broken bleeding horns upon arrival will not be accepted.
- **Ear Tags:** **ALL ANIMALS MUST** be tagged with an approved CCIA tag. (i.e. series 300-304) and a **GREEN** sale tag with the lot number.
- **Pregnancy tests:** All Bred 2 year olds must be verified as bred and safe with calf. Yearling heifers will not need to be pregnancy tested but the consignor must verify that the said heifer is open and free of pregnancy.
- **Semen Test:** All yearling bulls must have a breeding evaluation performed by an accredited veterinarian. A completed copy of the form is to be forwarded to the SBA office prior to delivery and the original hard copy must accompany the animal upon delivery.
- **Brucellosis:** - No testing required.
- **Tuberculosis:** - No testing required.

The Consignor warrants that there has been no use of growth stimulants and that the animals shown or to be born to the animal shown are the product of natural breeding.
