After a quorum was established, the meeting was called to order by the President at 6:34pm.

PRESIDENT'S REPORT: (See attached President's Report)

Conrad touched on a few of the issues this past year including the weather, drought and fires. He mentioned Board member Kim Grimwade resigned in her first term following the death of her partner Vic Beissel in July. They had just begun to set up their bison ranch which is now on hold.

He talked about how he's working with the BC Cattleman's Association on wolf predation of livestock. Mentioned that Black Willow Bison had lost 4 animals this year to wolves which triggered this action. The BC Livestock Protection Program is funded by the province and administered by the BCCA. Currently bison losses are not covered by the program and he is working to have bison included.

He also brought to everyone's attention the Emergency Hay Supply Program feed location service. Anyone who is interested in more info can contact Greg at hay@cattlemen.bc.ca or call him at 250-241-5640.

LES KROEGER GIVES THE CBA REPORT:

Les began by mentioning that predation compensation for bison occurs in other provinces and encouraged BCBA to work with the BC Cattlemen's Association and all groups on this.

He mentioned the Bison Biosecurity Document which will assist producers with portable panels, chutes and gates.

Also he spoke about moving the National Convention to Alberta however they are getting mixed reviews on this. Also the possibility of making it a summer event and even moving it to Kamloops or Kelowna is worth discussing.

Carl Fis has been working on different policies including the mention of increasing membership fees however this was opposed by the Board who are concerned about declining membership.

Les gave a quick update on the convention and that there will be approx. 40 head available at the show and sale which Jack Auction is putting on November 21st, 2023.

Shariff added that there is a new person at the CBA office and that their focus will be on maintaining the herd registry. Also there will be some changes with marketing programs. Quick discussion on supply chain issues.

Danica asked about the funding available to support an initiative similar to Ontario where all member ranch owners got a membership sign to put on their front gates.

GOVERNMENT SPEAKERS:

Julie Marie Hughes began with a quick correction on inventory numbers. Numbers look higher due to a large farm in Northern region having moved in with a large number of animals. Licenced producers still the same. Julie offered again to send out info to ranches and to reach out if needed to help get numbers up.

Quick report on a feral animals. 12-30 head – at least 1 has an ear tag. No one is claiming ownership.

Conrad gives a quick run down on the 2 feral herds currently running through the province. One near Nicola Valley and one near Butler Ridge. Also asks the group to share any ideas to get these animals under control. Danica suggests find their pattern and corral them.

Conrad suggested if Julie is able to find out tag numbers then it may be easy to identify who owns the animals. Danica suggest drone technology. Julie will look into this. Conrad also offers the groups help to Laura and Julie any time they need it.

Danica suggests a contact list be made of who to call and what steps to take in these situations also in case of wild fires etc. A case reference file number when you have to call about an issue a few times would be handy. Julie and Laura offer to prepare one and distribute to the group.

Laura mentions that she has a list of contact and support info re: the funding programs drought and wild fire for producers that have been affected. She will pass on to Conrad to distribute.

Natalie Belisle introduced herself and gave the group her contact details natalie.belisle@agr.gc.ca, 236-330-3443 if anyone has questions about Agri-Food and Agriculture programs. Conrad asked her for a link to info and programs and she agreed to send it out for dispersal.
